## **COMMISSION NOTICE**

### **To all participants: Oklahoma Association on Problem and Compulsive Gambling Statewide Self-Exclusion Program**

This notice implements immediate changes to all Muscogee (Creek) Nation gaming facilities. Effective October \_\_\_\_, 2018, the Muscogee (Creek) Nation (MCN) began participating in the Statewide Self Exclusion program offered by the Oklahoma Association of Problem and Compulsive Gambling (OAPCG).

The following MCN establishments are now a part of the OAPCG State Wide Self Exclusion program:

- 1) River Sprit Casino and Resort / Margaritaville
- 2) Creek Nation Casino-Muscogee, and the Creek Nation Travel Plaza, Muscogee
- 3) One Fire Casino and the Creek Nation Travel Plaza, Okmulgee
- 4) Creek Nation Casino-Duck Creek
- 5) Creek Nation Casino-Bristow
- 6) Creek Nation Casino-Okemah
- 7) Creek Nation Casino-Holdenville
- 8) Creek Nation Casino-Checotah
- 9) Creek Nation Casino-Eufaula

OAPCG offers a statewide self-exclusion program, with tribal cooperation, to those individuals or for those who would like to voluntarily ban themselves from participating Oklahoma tribal casinos. A complete list of participating agencies can be found at [www.oapcg.org](http://www.oapcg.org) and is updated periodically.

It is not the responsibility of OAPCG, the tribe, or the casino to exclude you from participating facilities. Please understand that the MCN shall employ its' best efforts to exclude participants from entry into MCN casino facilities. However, the ultimate responsibility belongs to you. By participating in this ban, you are excluded from MCN's

current establishments and any future MCN gaming or Travel Plaza establishments


You are receiving this letter because you are an active participant of the Statewide Self-Exclusion program. If you wish to have your name removed from the Muscogee (Creek) Nation's statewide ban list, please submit the provided form within sixty (60) days from the date of this letter.

No further action is required if you wish to remain active in the Statewide Self-Exclusion program, including the above MCN gaming facilities.

Be aware that completing the attached form will not remove you from the list of any other participating tribe. Nor will you be removed from any current ban issued by any Muscogee (Creek) Nation Casino or the Muscogee (Creek) Nation Gaming Commission.

Upon due notification, any persons on the Statewide Self-Exclusion list will be subject to civil and criminal prosecution should they enter into any participating casino(s).
